The United States District Court for the Northern District of Florida will hold a Naturalization Ceremony **Friday, November 16th, 2018, at 11:00 AM**, at the National Naval Aviation Museum onboard NAS Pensacola. The museum is located at 1750 Radford Blvd, Pensacola. Visitors to NAS Pensacola must use the West Gate entrance off Blue Angel Parkway. Three hundred (300) candidates are expected to take the oath of citizenship.

The Honorable M. Casey Rodgers, United States District Judge will preside at the ceremony, joined by the Honorable Lacey A. Collier, Senior United States District Judge and the Honorable Gary L. Bergosh, First Judicial Circuit Judge, State of Florida, Escambia County.

Seventh grade students from Ransom Middle School will attend the event. The students will assist in the ceremony by leading in the Pledge of Allegiance and two students have been selected to present their essays on "What it means to be an American."

Dr. Leo Day will perform the National Anthem and a Patriotic Celebration of Song.
